SUBJECT: **Nominating Committee Report: Proposed Slate for FY 2008**

This Report of the Nominating Committee was initially distributed to the Commission on May 4, 2007, 30 days or more prior to the Annual Meeting Per Article V, Section 2 of the Commission Bylaws.

The Nominating Committee met on April 25th 2007 to consider nominations for Officers and Executive Committee members for FY 2008. Prior to consideration of the slate, the RPC Chair solicited interest from the general membership at the April 11th Commission meeting, and a general solicitation was place on the agenda sent to all members. The Committee reviewed bylaw requirements, potential candidates, and reaffirmed the general objective of officers succeeding from Secretary, to Vice Chair and then to Chair, noting however that, upon request, the Vice Chair last year had not succeeded to the Chair. Glenn Coppelman agreed to serve as Chair and return as Treasurer after serving as Chair and past Chair. Going forward, the objective is to return to the normal succession. Regarding new members to fill two vacant positions, B. Goodrich (Stratham) agreed to serve and the members suggested that J. Kennedy (Brentwood) be asked to join

Based on this information, a slate of officers and executive committee members was developed. The proposed slate for FY 2008 is listed below. Several of the nominations were made subject to confirmation calls; all have since been confirmed. Additional nominations will be accepted from the floor during the Annual Meeting.
