Attached is a table that details the changes that Amendment #1 proposes to make to the 2015-2018 Transportation Improvement Program (TIP) within the Rockingham Planning Commission. There are fifty one (51) project changes proposed and these are summarized in the table below. Additional data regarding each project is on the RPC website (<u>www.rpc-nh.org</u>) including how the project is currently programmed and the proposed changes. The MPO is conducting a 10 day public comment period on Amendment 1 that will begin on July 19th, 2015 and concludes on July 28th, 2015. A final opportunity for comments will be during the public hearing at the **July 29th**, **2015** *RPC Meeting* (7:00 PM) at the Rye Town Library (581 Washington Road, Rye).

Analysis

This amendment consists of the changes to 51 regional projects and statewide programs. The projects listed with a shaded first line are those that we are expecting to receive updated information from DOT, and as such the information listed in this summary may not be reflected in the revision report posted on the MPO website. Recommendation

Based on the information provided regarding the movement of projects in time, and changes in scope and cost, staff concludes that:

- The fiscal constraint of the TIP/STIP is maintained according to the DOT fiscal constraint documentation which is included in the informational packet on the RPC website.
- As of July 20, 2013 all of New Hampshire is unclassifiable/attainment for the 2008 8-Hour Ozone National Ambient Air Quality Standard (the 2008 ozone standard) and the 1997 8-Hour Ozone National Ambient Air Quality Standard (the 1997 ozone standard) is revoked for

transportation conformity purposes in the Boston-Manchester-Portsmouth (SE), NH area. For this reason no air quality conformity analysis is necessary.

• Consistent with the RPC's Public Participation Process, this notice and comment period is also intended to meet FTA requirements for public comment on the programs of transit projects put forward by NHDOT, UNH and the COAST and CART transit systems.

Recommend that the TAC recommend approval of TIP Amendment #1 by the MPO Policy Committee.
