# **MEMORANDUM**

RE: RPC Member Services Survey Raw Results

Last summer RPC staff developed a survey for distribution to RPC member communities asking a range of questions about RPC services. Questions addressed use and evaluation of current services; and levels of interest in potential new services RPC is considering offering on a supplemental fee basis.

An invitation to take the web-based survey was sent in late May to the following lists maintained by RPC:

- Municipal Managers & Administrators
- Professional Planners
- DPW Directors & Road Agents
- Chairs of Municipal Boards & Committees:
  - Select Board Chairs
  - Planning Board Chairs
  - Conservation Commission Chairs
  - Zoning Board of Adjustment Chairs
  - Conservation Commission Chairs
  - Energy Committee Chairs
  - Economic Development Committee Chairs

In all RPC received 61 responses to the survey from 25 communities in the region. No responses were received from the towns of Epping or Newfields. Summary results from the survey are attached for review in advance of Wednesday's meeting.

# **RPC Member Services Survey - Key Findings**

- Q1 Responses Fifty-nine (61) responses from 25 of the 27 communities in the RPC region. Number of responses varied by community, with a high of five (5) individual responses each from Seabrook and Stratham, four communities with four responses each, five with three (3) responses, two communities with two and a single response from eleven communities.
- Q2 &Q3 Municipal Staff Role Most common municipal roles were Resident (28), Planning Board (27) and Municipal Staff (21). Eleven (12) RPC Commissioners completed the survey. Most frequent municipal staff roles self-identified were Town Administrators/Managers (8) and Planning Department Staff (5)
- Q4 Current Services Current RPC services most commonly cited included: Master Plan Updates (36), Zoning Ordinance Updates (33), Updates to Other Regulations (25), Mapping & Data Analysis (24), Circuit Riders (21), Community Surveys (21), Technical Training for Staff & Boards (18) and Hazard Mitigation planning (18).
- **Q5 Current Services/Open Ended** (29 Responses) Open-ended responses on current services found to be 'particularly useful' highlighted Circuit Riding (10), Master Plan updates (7), Coastal Adaptation (3), Zoning Ordinance Updates (3), Transportation Services (4) and Housing (3).
- Q6 How to Improve/Open Ended (22 Responses) The most common response here was essentially "keep doing what you're doing". Three points came up more than once: improving communication to let communities and the public know about services we offer and current work (cited 3x); providing assistance to Heritage Commissions with historic/cultural preservation work (2x); serving as a liaison with NHDOT (2x). Other points requested once included assistance with identifying grant funding for local planning efforts, mapping of archaeological sites, refining build-out analyses to show impact on emergency services and school, and increased focus on project implementation beyond initial planning.
- Q7 New/Expanded Services (40 Responses) Several potential new or expanded services stood out in respondent interest. These included:
  - Expanded Mapping/GIS Services (54% Very Useful/Weighted Avg. 2.1 out of 3.0);
  - Community Needs Assessment/Master Plan Surveys (70% Very Useful/WA 2.45);
  - Expanded Land Use Board Trainings (49% Very Useful/WA 2.21);
  - Part-Time TA for Conservation Commissions (50% Very Useful/WA 2.10),
  - MS4 Permit Development/Implementation (51% Very Useful/WA 1.97)
  - Other included TA for ZBAs (WA 1.84) and Review of Traffic Impact Analyses (WA1.91)
